Hydro One and Avista are looking forward to the commissioner workshop that will be held on Monday, February 26. The Hydro One participants must travel from Toronto, so the workshop involves three days of travel for the Hydro One participants. In order to make travel arrangements and ensure that the appropriate individuals from Hydro One are scheduled to attend, we have

several questions that we are hoping you can answer within the next few days:

- (1) In the Joint Application, Hydro One's witnesses are CEO Mayo Schmidt, Senior Vice President of Finance Chris Lopez, and Executive Vice President of Customer Care Ferio Pugliese.
