NORTHWEST INDUSTRIAL GAS USERS' NOTICE OF INTENT TO REQUEST INTERVENOR FUNDING

Pursuant to OAR § 860-001-0120 and the Third Amended and Restated Intervenor Funding Agreement ("IFA"), approved by the Oregon Public Utility Commission ("Commission") in Order No. 15-335 on October 20, 2015, Northwest Industrial Gas Users ("NWIGU") hereby respectfully submits this Notice of Intent to Request an Issue Fund Grant in Docket No. UM 1897. Under the IFA, Notices of Intent are to be filed with Motions to Intervene.

As required by the IFA, NWIGU asserts the following:

- 1. UM 1897 is an Eligible Proceeding under the IFA. The IFA defines an Eligible Proceeding as "any Commission proceeding that directly affects one or more of the Participating Public Utilities." IFA, Section 1(c). UM 1897 will directly affect Avista Corporation ("Avista"), a Participating Public Utility under Section 1(k) of the IFA. Therefore, an Issue Fund Grant is permissible under Section 6.1 of the IFA.
- 2. As required by IFA Section 6.2, this Notice of Intent is being served on each affected Participating Public Utility, all pre-certified organizations, and all parties identified on the service list for UM 1897.
- 3. NWIGU identifies the Avista Issue Fund Account as the account from which NWIGU intends to request the Issue Fund Grant. The amount of the request will depend on the availability of funds in that account when NWIGU submits a budget.

- 4. NWIGU has been precertified under Section 5.2 of the IFA and OAR § 860-001-0120(3) as eligible to receive an Issue Fund Grant.
- 5. NWIGU will submit a budget in accordance with Section 6.3 of the IFA or the prehearing conference order in this proceeding.
