PREHEARING CONFERENCE
MEMORANDUM

On September 11, 2018, the Public Utility Commission of Oregon held a telephone prehearing conference in this docket. Representatives appeared on behalf of Tillamook People's Utility District, the Commission's Staff, and the Oregon Coast Alliance (ORCA). Intervenors Kurt Mizee, Doris Mast, David Mast, and Don Aufdermauer also appeared.

Cross Examination

At the conference I inquired regarding the current expectations for cross-examination. On behalf of ORCA, Sean Malone confirmed his intention to cross-examine the witnesses appearing on behalf of the TPUD and the Commission Staff. Mr. Mast also indicated his intent to engage in cross-examination.

No party has reserved the right to cross-examine any of the intervenor witnesses. Accordingly, I will receive the testimony and materials submitted by each of the intervenors into evidence upon receipt of a signed declaration under penalty of perjury attesting to the truth of their testimony and exhibits. I have attached a draft form for the submission of testimony under oath to this memorandum.

On September 7, 2018, the Commission Staff filed a motion requesting the admission of its pre-filed testimony and exhibits. I will rule on Staff's motion after Staff's witnesses have been excused at the hearing.

Hearing and Briefing Schedule

The hearing will be held in Tillamook on November 1, 2018. The hearing will commence at 1 PM and continue until completed. A separate notice for the hearing will be sent at a later time.

After the close of the conference the parties took up the matter of the briefing schedule. I am informed by Staff that the parties agreed to the following briefing schedule:
