On September 29, 2017, Cascade filed Advice No. O17-09-01 with a requested effective date of January 1, 2018. On December 4, 2017, the Company filed to extend the effective date until February 1, 2018. The filing was inadvertently not acted upon before the requested effective date causing the new adjustment mechanism called the Safety Cost Recovery Mechanism (SCRM), to become effective before it was fully vetted by Commission Staff.
