RULING

DISPOSITION: DEADLINES TO SUBMIT AND OBJECT TO MOTIONS TO ADMIT.

On November 15, 2023, the Public Utility Commission of Oregon held an evidentiary hearing in these proceedings. At the hearing, the parties raised questions regarding motions to admit evidence into the record, including public comments submitted but not yet moved into the record as part of testimony or another filing. This memorandum sets out deadlines and guidance for submitting and objecting to motions to admit evidence.

The parties shall file motions to admit evidence by 3:30 p.m. on November 22, 2023. Parties may file any objections to motions to admit evidence by 3:30 p.m. on November 29, 2023.

In the motions to admit, the parties should include any evidence that they want to be included in the record, with exhibits properly marked, and declarations supporting any pre-filed testimony submitted in these proceedings. The parties do not need to move to admit evidence already identified in the motions to admit evidence filed on September 7, 2018, the testimony and exhibits admitted into evidence in the ruling issued by Chief
