MOTION TO MODIFY PROCEDURAL SCHEDULE

(Expedited Consideration Requested)

In accordance with OAR 860-001-0420, PacifiCorp d/b/a Pacific Power (PacifiCorp) respectfully requests the Public Utility Commission of Oregon (Commission) issue an order suspending the procedural schedule in this docket. PacifiCorp, Commission Staff, the Oregon Citizens' Utility Board (CUB), the Alliance of Western Energy Consumers (AWEC), Calpine Energy Solutions, LLC (Calpine Solutions), Fred Meyer and Quality Food Centers (Fred Meyer), the Klamath Water Users Association (KWUA), NewSun Energy, the Oregon Farm Bureau Federation (OFBF), Northwest and Intermountain Power Producers Coalition (NIPPC), Small Business Utility Advocates (SBUA), Vitesse, LLC (Vitesse) and Walmart Inc. (Walmart) (collectively, Parties) are working on finalizing settlements on all but one remaining issue in this proceeding. The remaining contested issue concerns whether a direct access customer participating in a three-year opt-out program can switch to the five-year optout program prior to the end of the customer's three-year opt-out term. Suspension of the procedural schedule will allow parties time to file the settlements and supporting testimony. Because Parties' prehearing briefs and cross-examination statements and exhibits are due on September 2, 2022 and the evidentiary hearing is scheduled for September 8, 2022,

PacifiCorp requests expedited treatment of this motion in accordance with OAR 860-001-0420(6).

Subject to the Commission's schedule, the Parties propose the following revised schedule:
