THIRD PARTIAL STIPULATION

1           Concurrently with this Motion, PacifiCorp, d/b/a Pacific Power (PacifiCorp) is filing a  
2 Third Partial Stipulation and supporting joint testimony resolving all remaining issues in this  
3 docket, except for two discrete issues, as outlined in the Third Partial Stipulation. This stipulation  
4 is joined by PacifiCorp, Staff of the Public Utility Commission of Oregon, the Oregon Citizens'
