PACIFICORP’S MOTION TO ADMIT
FIRST AND SECOND PARTIAL
STIPULATIONS AND REQUEST FOR
WAIVER

1 Concurrently with this Motion and Request for Waiver, PacifiCorp, d/b/a Pacific Power
2 (PacifiCorp) is filing two partial stipulations in this docket: (1) a first partial stipulation addressing
3 wildfire mitigation and vegetation management issues, joined by PacifiCorp, Staff of the Public
4 Utility Commission of Oregon (Staff) and the Oregon Citizens’ Utility Board (CUB), to which no
5 party objects; and (2) a second partial stipulation reflecting resolution of certain revenue
6 requirement issues, joined by PacifiCorp, Staff, CUB, the Alliance of Western Energy Consumers,
7 Walmart Inc., Calpine Energy Solutions, LLC, the Klamath Water Users Association, Oregon
8 Farm Bureau Federation, and Vitesse, LLC (together, the Stipulating Parties), to which no party
9 objects. On behalf of the Stipulating Parties, PacifiCorp moves to admit the two partial stipulations
10 into the record in this proceeding under OAR 860-001-0350(7)(b). Further, PacifiCorp requests
11 that the Public Utility Commission of Oregon (Commission) waive the requirement in OAR 860-
12 001-0350(7)(a) that settlements be accompanied by joint testimony or a supporting brief when
13 filed.

14 The Stipulating Parties are filing these stipulations immediately upon execution to notify
15 the Commission that the Stipulating Parties have resolved several issues raised in this docket. The

1 Stipulating Parties plan to offer supporting briefing for the stipulations in their prehearing briefs,
2 due Friday, September 2, 2022.

3 For the foregoing reasons, PacifiCorp asks the Commission to accept the stipulations for
4 filing, admit them into the record in this proceeding, and waive the requirement in OAR 860-001-
5 0350(7)(a) that a supporting joint brief or testimony be filed contemporaneously.
