Please refer to Exhibit PAC/1110. The proposed increase from this particular proceeding inclusive of adjustment schedules is \$82.171 million or 6.6 percent.

- (a) In this proceeding, the Company is not requesting a specific recovery of costs in an automatic adjustment clause (AAC), amortization, or other rate adjustment outside of its request to base rates and the Rate Mitigation Adjustment (Schedule 299) and the cancellation of the Oregon Corporate Activity Tax Recovery Adjustment (Schedule 104) that are included in its \$82.171 million or 6.6 percent price increase.
