In compliance with Order No. 22-459 and at the request of Public Utility Commission of Oregon (Commission) Staff, PacifiCorp d/b/a Pacific Power (PacifiCorp or the Company) submits for filing a proposed tariff sheet associated with Tariff P.U.C. OR No. 36, which sets forth all rates, tolls, charges, rules, and regulations applicable to electric service in Oregon. The purpose of this filing is to confirm that the rates for late payments and customer deposit interest approved in Order No. 22-459 are reflected in PacifiCorp's billing system and tariffs effective January 1, 2023. A less than statutory notice application is included with this filing.

In Order No. 22-459, the Commission approved a late payment rate of 2.2 percent and an annual interest rate of 4.5 percent on customer deposits for calendar year 2023. PacifiCorp is in compliance with Order No. 22-459 and has reflected these rates in its billing system and tariffs as follows:

- The late payment fee percentage is reflected in the Company's tariff Schedule 300 Charges as Defined by the Rules and Regulations, Sheet No. 300-2 to be effective January 1, 2023.
- The annual interest rate for customer deposits is addressed in the Company's tariff Rule 9 General Rules and Regulations Deposit, in section F on Sheet No. R9-5. Section F states:

The Company shall pay interest on deposits at a rate prescribed by order of the Public Utility Commission of Oregon. Interest on a deposit shall accrue annually and shall be credited to the Customer's account on the first statement following the anniversary or the accrual date. Interest on deposits held for less than a full year will be prorated.
