22 Utility Reform Project, Lloyd K. Marbet, and Colleen O'Neil [hereinafter URP]
23 move to alter the schedule adopted in the Conference Report dated December 21,
24 2007.

25 That schedule included filings by the parties to "indicate whether there are any
26 outstanding motions from Phase I that the Commission has not yet resolved that
27 they still wish to pursue" and "a list of the testimony and exhibits submitted in
28 Phase I, including exhibit number and date filed."

29 Compiling this information is much more time-consuming than anticipated by
30 undersigned counsel. It requires re-reading 345 pages of transcripts from a hearing
31 that occurred over two years ago, particularly to identify cross-examination exhibits

1 and whether each was admitted or not. It also requires reviewing numerous
2 discovery motions and documents.

3 We propose that the parties active in Phase I (URP, PGE, and Staff) instead
4 informally exchange lists of motions and exhibits and then make a joint filing of that
5 information to the Commission on January 29, 2008. We believe that no party is
6 prejudiced by this change.
