**URP MOTION FOR EXTENSION**  
**OF TIME TO RESPONSE TO PGE**  
**MOTION TO STRIKE**

11 On June 29, 2005, URP sent this electronic message by email to the OPUC  
12 and the service list in this matter:

13 We have received from PGE a motion to strike portions of the testimony  
14 submitted by Utility Reform Project.

15  
16 We request that the response to this motion be due on July 8. The  
17 extension is needed, because on June 11, undersigned counsel had a slip  
18 that resurrected severe back pain he had last experienced five years ago.  
19 He has since then not been able to perform such tasks and sitting down  
20 without doses of painkillers with marked effects on alertness. While a  
21 similar condition experienced in 2000 abated after two weeks, this condition  
22 has remained the same and continues to require a narcotic painkiller that  
23 affects ability to concentrate.

25 We see no prejudice to any party of the granting of this motion.

26 We also seek leave to file this motion in this electronic form only.

30 By order of July 1, 2005, the ALJ rescinded the earlier order granting leave to file  
31 this motion in electronic form only. Consequently, URP, by means of this document,

1 is hereby filing the same motion in paper form.
