21 At the close of the hearing on August 30, 2005, a schedule was announced
22 for the parties to file affidavits of non-examined witnesses and to file documents
23 pertaining to testimony (motions to strike testimony on certain grounds; possibly
24 statements adopting testimony originally submitted by others; etc.) by September 2,
25 2005.

26 Due to logistical and time management problems in meeting that date, Utility
27 Reform Project (URP) moves that the deadline be changed to noon on September
28 6, 2005.

29 Counsel for PGE was contacted on August 30 and does not object to this
30 change, provided "this extension shall not be used as a reason to extend the

1 schedule for post hearing briefs that would otherwise apply." URP does not object
2 to this condition.

3 Counsel for OPUC Staff was contacted by email on August 31 (3:58 p.m.) and
4 has yet to reply.
