22	Oregon. Wah Chang is an industrial customer of PacifiCorp. As a customer of an electric public		
23	utility subject to supervision and regulation by the Commission, Wah Chang has an interest in		
24	the Commission's authority to redress past rates. In particular, Wah Chang seeks such redress in		
25	Wah Chang v. PacifiCorp, Docket UM 1002.

9	Wah Chang has a direct and substantial interest in this proceeding, in which the					
10	Commission has announced it will begin an investigation into its delegated authority to engage in					
11	retroactive ratemaking. In re Application of Portland General Electric Co. for an Investigation					
12	into Least Cost Plan Plant Retirement, DR10/UE88/UM 989, Order 07-157 at 9 (April 19,					
13	2007). The Commission has observed that "[g]iven the generality and breadth of this issue, we					
14	expect that other parties, in addition to those now active in these joint remand proceedings, will					
15	want to participate." Id.

17	Wah Chang's participation in this docket could assist the Commission in resolving the					
18	issues. Wah Chang will not unreasonably broaden the issues, burden the record, or unreasonably					
19	delay the proceedings.
