,1	The OS District Court also has before it the interpretation of the waiver Order in the Complainants Motion
2	for Summary Judgment that will be heard after the July 22, 2010 hearing date which is essential to be resolved even
3	if the PUC has jurisdiction.
4	The Oregon Court of Appeals has been advised that the PUC has set a briefing schedule and that it has been
5	informed of the Motion. While I have not heard back from either Mr. Graham or Mr. Jones, it would seem that the
6	PUC has an interest in an orderly process rather than one which is hurried at the Court of Appeals.
7	Complainants have been directed by the US District Court Judge Brown to prepare for the July 22, 2010
-8	hearing by cooperating with each other on matters that she has requested due by July 8, 2010. While Mr. Reichman
9	is under no pressure in this pending case the burden of doing it all is somewhat more taxing to this office given the
10	time demands. I believe that the Commission will be served by waiting at least until the Court of Appeals reviews
	the Petition and the Expedited Motion and respectfully request at least a two week extension and a stay until the
11	Court of Appeals acts on the Motion to Stay. The PUC has the authority to so rule now.
12	Upon conferring with Lawrence Reichman, counsel for Qwest Corporation, he has indicated that Qwest
13	would oppose this request.
14	This motion is supported by the Declaration of Frank G. Patrick attached.
