

2 Motion to Modify Schedule to the Public Utility Commission of Oregon (Commission).
3 PacifiCorp and the other parties actively participating in this docket—Commission Staff,
4 the Citizens’ Utility Board of Oregon (CUB), and the Industrial Customers of Northwest
5 Utilities (ICNU), with PacifiCorp referenced as “the Parties”—discussed rescheduling the
