**Introduction.**

Pursuant to OAR 860-001-0420 and the First Amended and Restated Intervenor Funding Agreement Article 6.5 and 6.7 CUB hereby moves to amend its previously filed December 3, 2010 Issue Fund Budget for this docket. The Amendment will decrease the amount of funds requested by CUB. CUB has discussed this amendment with counsel for ICNU pursuant to OAR 860-001-0420(3).

**Argument.**

CUB makes this filing for the reason that an all active party Stipulation has now been filed with the Commission in this UM 1050 docket. CUB does not anticipate significant additional expense in this docket and has need of the funds for immediate use in the PacifiCorp UE 227 TAM docket.

Simultaneous with this filing CUB is also filing an Issue Fund budget in the UE 227 docket. Without the immediate release of funds from this UM 1050 docket back to

the PacifiCorp Issue Fund there will be no money in the PacifiCorp Issue fund for use by CUB in the prosecution of the UE 227 proceeding.

### **Conclusion**

CUB respectfully seeks release of \$13,653 from the UM 1050 docket back to the PacifiCorp Issue Fund. CUB's December 3, 2010 proposed budget filing sought \$47,200. The reduction to the proposed budget that CUB seeks today reduces the amount of Issue Funds sought to \$33,547.
