**RE: Advice No. 17-11 Schedule 800 Service Maps Update**

Portland General Electric Company (PGE) submits this filing pursuant to Oregon Revised Statutes (ORS) 756.010(8) and 757.205, and Oregon Administrative Rule (OAR) 860-022-0025, for filing a proposed tariff sheet associated with Tariff P.U.C. No. 18, with a requested effective date of June 28, 2017:

Third Revision of Sheet No. 800-1

This filing makes a number of housekeeping changes to Schedule 800 Service Maps. Updates include; Geospatial (GIS) Products offered, and clarifying language regarding Map Requests and Payment.

With regard to changes to Geospatial (GIS) Products, language was added that Hardcopy Maps and Electronic Maps are available by Quarter Sections. Goggle Earth Files and Geodata Files are now offered the following other minor changes are being made: adding that maps are available in standard and large format; the reference to special request GRID data maps is removed and is now listed as customized hard copy or electronic map or data file; and clarifying language is added regarding one hour minimum for Special Order.

Additional language was added to Map Requests. In addition to calling Customer Service, Customers can contact PGE's GIS department at the email address provided in Schedule 800. Lastly, clarifying language in the Payment section now reads that payment is required at the time of products and/or services.

To satisfy the requirements of OAR 860-022-0025, PGE responds as follows:  
As this filing proposes "changes to an existing schedule" under OAR 860-022-0025(2), PGE provides the following additional information:


