SIERRA CLUB'S COMMENTS

The Sierra Club respectfully submits the following comments in the above-captioned matter. Overall, the Sierra Club supports the Commission's changes to OAR Chapter 860

Divisions 001-082 because they nearly eliminate the need to file and serve paper documents.

However, in the case of filings that still require a physical format, the proposed changes would reduce the time available for intervenors to respond in contested cases and declaratory ruling proceedings. Like CUB, Sierra Club opposes the changes that cover the due dates for filing and service of confidential paper copies, given the potential loss of several days of preparation time in cases where confidential material is a component of the filing.

Under the current rules, for intervenors submitting materials on CD, DVD or submitting confidential pages, the package containing those materials need only be post-marked on the filing due date. Under the proposed changes, intervenors would be required to ensure that those same materials would arrive on the due date. Sierra Club agrees with CUB that the Commission should not adopt this revision because it would disproportionately burden intervenors but does not evidence a strong, countervailing benefit to the Commission or utilities. Like CUB, Sierra Club frequently finds itself finalizing voluminous submissions on filing day. For this reason, the filing arrangement should remain the same for the transmittal of confidential

material, which gives parties filing confidential material the same response time as those parties

not submitting protected information. In the alternative, the Commission could explore allowing

for the e-filing of confidential information, or simply extend the filing deadlines by 3 days to

accommodate intervenors like CUB.

Finally, Sierra Club is curious why the Commission would strike the request that

documents be printed on both sides of the page on recycled paper when possible.³ While this

may seem trivial given the move to e-filing, it remains an admirable policy that can translate into

meaningful reductions in waste; accordingly, please keep it on the books.

Sierra Club appreciates the opportunity to comment on the Commission's efforts to

streamline its processes, and make e-filing more accessible. Still, as described above, we

respectfully request that you reconsider the extra burden two of the proposed changes could have

on intervenors and the environment.
