In accordance with your June 9, 2005 Memorandum, the Klamath Off-Project Water Users, Inc. ("KOPWU") submits this letter regarding procedural issues in Oregon Public Utility Commission ("OPUC" or the "Commission") Docket No. UE 170. With respect to the questions regarding oral argument, KOPWU requests that the Commission hold oral argument in UE 170. Counsel for KOPWU is *unavailable* to participate on August 1, 11, 15, and 17, 2005.

KOPWU's primary interest in UE 170 relates to PacifiCorp's proposal to move KOPWU's members to standard irrigation tariffs in 2006. A prehearing conference has been scheduled for June 24, 2005, to identify issues and establish a procedural schedule to address the appropriate rates for Klamath irrigation customers. At that prehearing conference, KOPWU intends to request that the Commission address the issues regarding the appropriate rates for Klamath irrigation customers independently of the other general rate case issues. Specifically, KOPWU believes that the Commission should schedule a separate hearing and oral argument regarding the Klamath irrigation rates.

Given that the issues regarding the Klamath irrigation rates have only recently been shifted back into UE 170, KOPWU believes that it is appropriate to provide more time to address those issues than is provided by the current procedural schedule in UE 170. If the Commission establishes a separate procedural schedule that provides adequate time to address the specific issues regarding the Klamath irrigation rates, it may be unnecessary for KOPWU to participate in the oral argument related to other issues in UE 170.

With respect to the question of consolidating the power cost adjustment mechanism filing in UE 173 with the general rate case in UE 170, KOPWU has no position regarding that issue.

KOPWU appreciates the opportunity to comment.
