**Subject:** UE 170 - Joint Issues List

Judge Grant:

Earlier this afternoon, a proposed joint issues list regarding the electric rates for Klamath Basin irrigation customers was filed in UE 170. The Klamath Off-Project Water Users (KOPWU) was not among the parties supporting this list as the agreed-upon "joint" issues list in this proceeding. KOPWU does not disagree that the issues listed in the proposed joint issues list filed this afternoon should be considered in this proceeding; however, the discussions regarding the list made clear that KOPWU and certain parties disagree as to the meaning and scope of those issues. As such, although KOPWU appreciates the efforts of all parties involved in attempting to formulate an agreed-upon list, KOPWU is unable to support the proposed list as filed.

As you are aware, KOPWU, the Klamath Water Users Association, the Bureau of Reclamation, and the US Fish and Wildlife Service filed a proposed issues list for this proceeding last Friday, July 29, 2005. KOPWU believes that it is necessary to address all of the topics in that list to fully examine the three issues identified by the Commission in Order No. 05-726. KOPWU supports the inclusion of all of those topics in any issues list established in this proceeding.
