OBJECTION TO NATIONAL ACTION NETWORK OREGON'S REQUEST TO  
INTERVENE

I, Bonnie C. Lucas, object to National Action Network Oregon's request to intervene for the following reasons:

1) Petitioner, National Action Network Oregon (NANO), fails to state in its request how it is interested in these proceedings, the issues it intends to raise at the proceedings, or any special knowledge or expertise it has that would assist the Commission in resolving the issues at hand, as is required by OAR 860-001-0300.

2) Petitioner does not state she has any special expertise with water systems, she has not done any independent analysis of the situation, she has not checked any facts she cites, she only recites what Mrs. Bedsole told her and re-stated almost verbatim what Mrs. Bedsole herself has already asserted in these proceedings. The addition of Petitioner will not add anything to these proceedings, nor will it help the Commission to reach a decision.

3) I want these proceedings to end. Adding additional parties with no independent useful information does not help the process. A decision one way or the other will have no effect on Petitioner.
