There is no data for the idea that VIRs are inappropriately high. All real data actually shows quite the opposite.

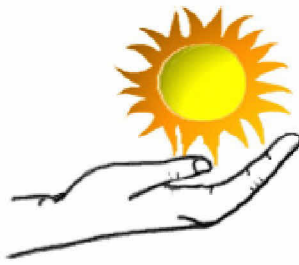

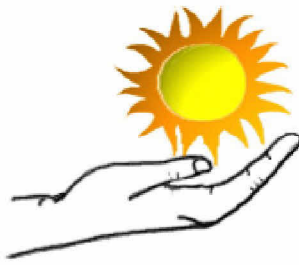
