STAFF'S SPECIFICATION COMMENTS

In accordance with the procedural schedule, Staff's comments address only Portland General Electric's (PGE) technical specifications for third-party engineer- procure-construct bids for capacity or baseload resources on PGE's sites. The Independent Evaluator (IE) will file an assessment of these technical specifications on May 11, 2012 as well. Staff has discussed the technical specifications with the IE and understands the IE has no substantial concerns with them. Staff comments are limited to whether the technical specifications are commercially attainable. Staff believes that PGE's technical specifications are commercially attainable by a qualified EPC provider. Staff understands interveners in this docket may offer specification comments beyond commercial attainability. In the Staff Report for the Public Meeting, Staff will address the IE's comments, intervener comments and PGE reply comments, and offer a recommendation for consideration by the Commission.
