Portland General Electric (PGE) hereby submits an Attestation for PGE's Tucannon River Wind Farm. The Attestation is submitted in compliance with Commission Order No. 14-422. The Attestation is submitted in compliance with Tariff Schedule 122, Special Condition 4, which states:

The in-service date for the new renewable resource project or each separately identifiable project segment will be verified by an attestation from the Company stating that the specific renewable resource project, or project segment, has met requirements for being commercially operational and is in service.

Attachment A is the Attestation of Stephen Quennoz; Vice President, Nuclear Power & Supply/Generation; that Tucannon River Wind Farm is in commercial operation. As indicated in the Attestation, 100 percent of the wind turbines were producing power and connected to the transmission facilities as of December 15, 2014.
