This rulemaking implements Senate Bill 286 changes to ORS 757.991, effective June 2, 2015, increasing the amount of maximum civil penalties for gas storage and pipeline safety violation to comport with the Federal standards, and allowing the PUC to directly assess and collect the penalties. No comments were filed in response to the Notice of Proposed Rulemaking.

ORDER

DISPOSITION: MODIFICATIONS TO RULE ADOPTED

I. INTRODUCTION

In this order, we adopt changes to OAR 860-031-0035 to implement 2015 Senate Bill 286 changes to ORS 757.991. The changes to ORS 757.991 became effective on June 2, 2015. The changes to rule resulting from SB 286 increase the amount of the maximum civil penalties for gas storage and pipeline safety violations to comport with the Federal standards, and allow the PUC to directly assess and collect any such penalty. The maximum civil penalty is increased from \$10,000 to \$200,000 per event per day and the maximum penalty for a series of failures is raised from \$500,000 to \$2,000,000.

II. PROCEDURAL HISTORY

On June 9, 2015, we filed a Notice of Proposed Rulemaking and Statement of Need and Fiscal Impact for this rulemaking with the Secretary of State. On June 10, 2015, we provided notice to all interested persons on the service lists established under OAR 860-001-0030(1)(b) and to legislators specified in ORS 183.335(1)(d). Notice of the rulemaking was published in the July 2015 *Oregon Bulletin*. The notice established a comment due date of July 22, 2015. No comments were filed.

III. ORDER

IT IS ORDERED that:

1. The modifications to OAR 860-031-0035, as shown in Appendix A, are adopted.

860-031-0035 Civil Penalties

(1) Civil penalties for failure to comply with gas pipeline safety rules or regulations shall beare based on the gravity of the violation, the extent of the operators' past violations, and other matters as justice may require.

(2) NOTE: ORS 756.180 provides for the enjoining of a violation of the utility laws. ORS 757.991 provides for penalties for failure to comply with gas pipeline safety rules or regulations of \$10,000200,000 per day, to a maximum of \$500,0002,000,000 for any related series of failures.
