Magna5 LLC ("Company") hereby notifies the Public Utility Commission of Oregon ("Commission") that effective November 1, 2016 the Company is changing its name from X5 OpCo LLC to **Magna5** LLC. On that date the Company will begin doing business as Magna5 LLC. Evidence of the Oregon Secretary of State *Acknowledgement Letter* reflecting the name change is attached.

On March 17, 2015, X5 OpCo LLC was granted authority to provide telecommunications service in Oregon as a Competitive provider in Docket Nos. CP 1572 and 1126.¹ This name change is part of a rebranding initiative associated with the completion of a Commission-approved asset acquisition in Oregon and throughout the U.S., and is not the result of a corporate reorganization or change of control. The Company's operations are otherwise unchanged. Company subscribers are being notified of the name change via billing insert and separate letter.
