North County Communications Corporation of Oregon ("NCC"), with the concurrence of Qwest Corporation d/b/a CenturyLink QC "(CTL"), files this joint status report concerning IC 16 and a related matter pending before the Arizona Corporation Commission ("ACC").

The matter before the ACC – *NCC Corp. of Arizona v. Qwest*, Docket Nos. T-03335A-12-0368 and T-01051B-12-0368 – remains in abeyance. On December 23, 2013, the U.S. District Court for the District of Arizona granted CTL's and the ACC's cross-motions for summary judgment, and denied NCC's motion for summary judgment, in *NCC Corp. of Ariz. v. Qwest, et al.*, U.S.D.C., D.Ariz., Case No. 2:13-cv-00466-DGC. NCC filed a Notice of Appeal on January 21, 2014, and the appeal is now pending before the U.S. Court of Appeals for the Ninth Circuit as Case. No. 14-15115.

In the U.S. District Court for the District of Oregon, oral argument in *NCC Corp. of Ore. v. Qwest Corp., et al.*, U.S.D.C., D.Ore., Case No. 3:13-cv-00375-BR was held on February 13, 2014, and on March 5, 2014, the District Court granted CTL's and the OPUC's cross-motions for summary judgment, and denied NCC's motion for summary judgment, affirming all terms of the interconnection agreements approved by the Commission. NCC filed a Notice of Appeal on

March 31, 2014, and the appeal is now pending before the U.S. Court of Appeals for the Ninth Circuit as Case. No. 14-35254. In response to a joint motion filed by all parties in the two appeal proceedings, the Ninth Circuit consolidated the appeals of Case Nos. 14-15115 and 14-35254 on April 21, 2014. NCC's opening briefs are due July 9, 2014. The deadline for response briefs for CTL, the ACC, and the OPUC is currently scheduled for August 8, 2014.

The parties respectfully request that this proceeding continue to be held in abeyance.
