JOINT STATUS REPORT
AUGUST 19, 2013

North County Communications Corporation (“NCC”), with the concurrence of Qwest Corporation d/b/a CenturyLink QC (“CTL”), files this joint status report concerning the related matter currently pending before the Arizona Corporation Commission (“ACC”).

The matter of *North County Communications Corp. of Arizona v. Qwest Corporation d/b/a CenturyLink QC*, ACC Docket Nos. T-03335A-12-0368 and T-01051B-12-0368, before the ACC remains in abeyance until the U.S. District Court, D. Ariz., acts on a related appeal filed by NCC (*North County Communications Corp. of Ariz. v. Qwest Corp., et al.*, U.S.D.C., D.Ariz., Case No. 2:13-cv-00466-DGC). On June 11, 2013, the District Court in Arizona issued its Order Setting Schedule for Summary Judgment Briefing in that matter. Pursuant to the order, NCC filed its opening brief on August 15, 2013, and CTL and the Commission will submit their responses and cross-motions for summary judgment on September 30, 2013. NCC’s reply brief is due October 30, 2013. The District Court has set oral argument for December 5, 2013.

On June 11, 2013, the U.S. District Court, D. Ore., established a briefing schedule for *North County Communications Corp. of Ore. v. Qwest Corp., et al.*, U.S.D.C., D.Ore., Case No. 3:13-cv-00375-BR). Pursuant to that order, the parties submitted a Joint Statement of Agreed Facts on August 15, 2013. NCC's Motion for Summary Judgment is due August 30, 2013. Qwest's and the Oregon Commission's separate responses and Cross-Motions are due October 29, 2013. NCC's reply brief in support of its motion and response to Defendants' Cross-Motions are due December 13, 2013. Defendants' separate reply briefs in support of their motions are due January 10, 2014. The Court will schedule a Rule 16 Conference if further proceedings are necessary after resolution of the motions.

The parties respectfully request that this proceeding continue to be held in abeyance pending resolution of the federal district court matters.
