SUPPLEMENTAL STATUS REPORT MAY 16, 2014

North County Communications Corporation of Oregon ("NCC"), by and through undersigned counsel, submits this status report concerning IC 16, supplementing the joint status report submitted by NCC, with the concurrence of Qwest Corporation d/b/a CenturyLink QC ("CTL"), on May 2, 2014.

As noted in the May 2 joint status report, NCC of Arizona's appeal of the Arizona district court decision and NCC's appeal of the Oregon district court decision are pending before the U.S. Court of Appeals for the Ninth Circuit as Case Nos. 14-15115 and 14-35254, respectively. The Ninth Circuit consolidated the appeals of Case Nos. 14-15115 and 14-35254 on April 21, 2014. NCC's opening briefs are due July 9, 2014. The deadline for response briefs for CTL is currently scheduled for August 8, 2014.

Although the parties have respectfully requested that this proceeding continue to be held in abeyance pending the appeals, on May 16, 2014, CTL disconnected all of NCC's interconnection trunks that carry all traffic from CTL to NCC. As a result, NCC's customers are experiencing complete outages and cannot receive incoming calls that traverse the CTL network. This anticompetitive action disrupts the ubiquity of the phone network and violates FCC call blocking orders. As a result of the disconnection by CTL, NCC requests that the stay of this proceeding be lifted to address CTL's improper actions. In the alternative, CTL should be prohibited from blocking traffic pending final resolution of the issues before this Commission and the Ninth Circuit.
