JOINT STATUS REPORT

Pursuant to ALJ Arlow's December 5, 2012 ruling, North County Communications Corporation ("NCC"), with the concurrence of CenturyLink QC ("CTL"), files this joint status report concerning the related matter currently pending before the Arizona Corporation Commission ("ACC") and the parties' proposal to provide ALJ Arlow and the Commission with a subsequent joint update on or before April 30, 2013.

On January 31, 2013, CTL filed a Motion for Partial Summary Judgment in the ACC proceeding (*North County Communications Corp. of Arizona v. Qwest Corporation d/b/a CenturyLink QC*, Docket Nos. T-03335A-12-0368 and T-01051B-12-0368). NCC's response to the motion is due on March 7, 2013. Given the similarity of issues in IC 16 and the ACC matter, the parties believe it is most prudent and efficient to continue the stay in IC 16 at least until April 30, 2013, at which time the parties will provide a joint status report to the Commission and ALJ Arlow and proposed procedural schedule for moving forward with IC 16.
