## Re: Docket LC 53 - Idaho Power Company's 2011 Integrated Resource Plan

Dear Judge Grant:

On March 8, 2013, Staff filed a Motion to Establish Procedural Schedule related to the filing of Idaho Power Company's ("Idaho Power" or "Company") 2011 Integrated Resource Plan ("IRP") Update. The motion included an item for Idaho Power to present its 2011 IRP Update to the Public Utility Commission of Oregon ("Commission") at the regularly scheduled public meeting on April 9, 2013. Staff's motion noted that Idaho Power was unavailable on that date. However, as noted by Staff, Idaho Power was available for a special public meeting on March 29, April 1, or April 10.

On March 8, 2013, you issued a Ruling adopting Staff's proposed procedural schedule. In your ruling you indicated that Idaho Power should inform the Commission regarding the Company's availability to present its 2011 IRP Update to the Commission.

The purpose of this letter is to confirm that the dates identified in Staff's motion—March 29, April 1, or April 10—are Idaho Power's preferred dates to appear at a public meeting and present its 2011 IRP Update.
