During the prehearing conference held in this docket on April 4, 2018, you asked me, on behalf of Petitioner Tillamook PUD, to provide an update on the status of Tillamook County's land use proceedings following the then-pending decision by the County's Planning Commission.

On April 26, 2018, the County's Planning Commission took action on Tillamook PUD's land use applications, voting 5-0 to approve each of the three applications. The County issued notice of those decisions on May 4, 2018. An appeal of the Planning Commission's decision was later filed and the appeal is now pending before the County's Board of Commissioners with an initial hearing anticipated in July.
