## Re: PCN-2 – Tillamook People's Utility District's Land Use Status Update

Dear Judge Moser and Judge Allwein:

During the prehearing conference held in this docket on April 4, 2018, Administrative Law Judge Patrick Power requested that Petitioner Tillamook People's Utility District (Tillamook PUD) provide an update on the status of Tillamook County's land use proceedings relating to the Oceanside Transmission Line. Tillamook PUD has understood this to be a standing request and has filed updates in this docket from time to time as the various land use phases have concluded.

In our last update, we informed you that the Court of Appeals had affirmed the decision by the Land Use Board of Appeals ("LUBA"), which upheld all of the County's permitting decisions for the Oceanside Transmission Line. Following its affirmation of the County's land use approvals, and after the time for appealing the Court's decision to the Supreme Court lapsed, the Court issued its appellate judgment on August 5, 2019. LUBA then issued a Notice of Appellate Judgment on September 4, 2019. In that notice, LUBA confirmed that the Court's decision required no change to LUBA's approval of the County permits. A copy of that notice is attached.

Based on the foregoing, the County's land use proceedings have become final for all purposes and are no longer subject to any appeals processes.
