

I, James V. McCarthy, being duly sworn on oath, depose and say:

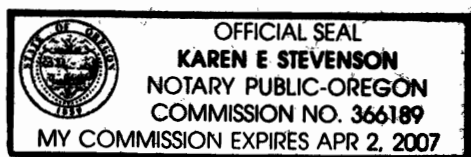
