The Citizens Utility Board of Oregon (CUB) files this Notice of Intent to Request an Issue Fund Grant in UE 233, pursuant to OAR 860-001-0120 and the Intervenor Funding Agreement by and Among Idaho Power Company and the Citizens' Utility Board of Oregon (IFA), approved by the Oregon Public Utility Commission (Commission) in Order No. 10-396 (October 13, 2010).

- Idaho Power Company (IPC) has filed its General Rate Case. The Commission will examine this filing in Docket No. UE 233.
- 2. UE 233 is an Eligible Proceeding under the IFA. The IFA defines an Eligible Proceeding as "any Commission proceeding that directly affects Idaho Power, including, but not limited to, rulemaking proceedings, declaratory ruling proceedings, and contested case proceedings, but does not include complaint proceedings if CUB initiates or causes to be initiated the complaint proceeding." - UE 233 will directly affect Idaho Power, which is a Participating Public Utility under Article 1(h) of the IFA.
- 4. As required by IFA Article 6.2, this Notice of Intent is being served upon Idaho Power, and all parties of record in the proceeding.
- 5. CUB identifies the 2011 Idaho Power Issue Fund Account as the account from which CUB intends to request the Issue Fund Grant.
- 6. CUB has been precertified under Article 5.1 of the IFA and OAR 860-001-0120(3)(a) as eligible to receive an Issue Fund Grant.
- 7. CUB will file a proposed budget with respect to the Issue Fund Grant, as provided in Article 6.3 of the IFA.
