Enclosed is PGE's April 1, 2014, MONET update for Docket UE 286. This update includes contracts and electric and gas forward curves as of February 27, 2014. This update also includes revised plant performance factors for forced outage rates based on 2010-2013 data for calendar year 2015. Net Variable Power Costs total \$573.1 million, a decrease of approximately \$7.2 million from the February 13, 2014 initial filing.


