Pursuant to Section 6.3 of the Third Amended and Restated Intervenor Funding Agreement (“IFA”) approved by the Oregon Public Utility Commission (“Commission”) by Order No. 15-335 (October 20, 2015), the Industrial Customers of Northwest Utilities (“ICNU”) files this Request for Amendment of Proposed Budget in Docket No. UE 307 (the “Proceeding”) for an increase of \$3,785.33 to its Issue Fund Grant for a new grant in the amount of \$24,893.33.

On May 18, 2016, ICNU submitted a proposed budget showing eligible expenses of \$26,385 and seeking an Issue Fund Grant in the amount of \$21,108. ICNU sought a \$8,560.20 Issue Fund Grant from the 2016 PacifiCorp Issue Fund and \$12,547.80 in reallocated funds from Docket No. UM 1719. On May 24, 2016, the Commission approved ICNU’s proposed budget by Order No. 16-200.

ICNU is now proposing an amendment to its budget showing eligible expenses of \$31,116.66, and is seeking an Issue Fund Grant in the amount of \$24,893.33. Since ICNU has unused Issue Fund Grants in Docket No. UM 1754, ICNU requests that \$3,785.33 be reallocated from the UM 1754 Issue Fund Grant for use in this proceeding.

Section 6.7 of the IFA states:

*Amendment of Proposed Budget: At any time during the proceeding, an intervenor who received Commission approval for an Issue Fund Grant may file to amend its budget and request additional funding due to unforeseen changes in the scope or complexity of issues, positions taken by other parties, changes in the schedule of the case, or other good cause. An intervenor with approved proposed budgets in multiple dockets may request to reallocate approved amounts between dockets by filing a request in both dockets.*

ICNU expects that its participation in this docket will require additional time and resources that were not foreseen, and which were not outlined in its original proposed budget in this proceeding. There are numerous contested issues in this proceeding, which will require more effort than originally anticipated.

Pursuant to Section 6.7 of the IFA, ICNU is filing a request for final payment in Docket No. UM 1754 at the same time it files this Request for Amendment of Proposed Budget.

Accordingly, ICNU respectfully requests that the Commission act on this Request for Amendment of Proposed Budget within fourteen days of receipt, as provided in Section 6.7 of the IFA, and issue an order reallocating funds from UM 1754 for a total Issue Fund Grant of \$24,893.33.
