RE: UE 308 – Planned Thermal Maintenance Update


Filing Center:

In accordance with OPUC Order No. 09-433 and the stipulation approved therein, PGE is providing this letter as notification of changes to the forecast of planned maintenance outages and testing for the Beaver, Boardman, Coyote Springs, Port Westward 1, and Port Westward 2 generating facilities. Collectively, PGE estimates these changes to result in a slight power cost increase (i.e., approximately \$300,000). PGE will include the revised forecast of planned maintenance outages and testing in its MONET update to be filed on July 15, 2016.

Detailed descriptions of the changes to the planned maintenance outage and testing schedules are enclosed as Attachment A. A work paper providing updates to the planned maintenance outage and testing schedules for the plants identified above is enclosed as Attachment B. Attachments A and B are protected information and subject to Protective Order No. 16-137.


