I am writing to let you know that NW Natural has modified its plans for the hearing on Friday in this docket. NW Natural has decided to waive cross-examination of Clean Energy's witness Warren Mitchell, and therefore will not need the 45 minute window it reserved at the prehearing conference this morning. Also, for this reason we will not be filing cross examination exhibits this afternoon. However, NW Natural would like to increase its estimate of the time required for the direct rebuttal of testimony of Barbara Summers from the 15 minutes it provided this morning to a total of 30 minutes.
