Re: Docket UM 1084, US Cellular Corporation Errata to Order No. 04-356

Staff has reviewed United States Cellular Corporation's (USCC's) December 9, 2005, request for issuance of an errata order to Order No. 04-356. Staff generally concurs with the requested corrections and supports the issuance of an errata order to correct the Appendix B wire center listings that were included in Order No. 04-356, USCC's original designation order.

However, Staff has identified two errors in Exhibit A of USCC's request. Exhibit A, which represents a corrected list of the wire centers comprising USCC's designated service area for federal universal service support purposes, shows CenturyTel of Eastern Oregon's study area code (SAC) as 532360, and CenturyTel of Oregon's SAC as 532395. The correct SAC for both CenturyTel of Oregon and CenturyTel of Eastern Oregon is 532361. Although these are two separate CenturyTel companies, they are treated as one study area for universal service purposes and therefore have only one SAC.

These corrections have minimal impact on USCC's request. Staff has contacted USCC regarding these corrections, and USCC agrees that the changes should be made.

Attached is a revised version of USCC's Exhibit A that includes the correct CenturyTel SAC. This list represents a corrected version of the Appendix B list in Order No. 04-356.
