

**CROSS EXAMINATION STATEMENT  
OF PACIFICORP**

1           PacifiCorp d/b/a Pacific Power (“PacifiCorp” or “Company”) waives cross-examination  
2 of all witnesses, but reserves its right to ask follow-up cross-examination questions of any  
3 witness questioned by another party or the Administrative Law Judge. The Company  
4 understands, however, that all parties in this case intend to waive cross-examination of all  
5 witnesses, so it does not anticipate the need for such cross-examination.

6           The parties have agreed that parties may offer data request responses into the record and  
7 request official notice of Commission orders and filings by motion. PacifiCorp intends to file  
8 such a motion prior to the hearing date. Pursuant to the Administrative Law Judge’s  
9 Memorandum of May 29, 2009, prior to the hearing date, the Company will also file an Affidavit  
10 of Pete Warnken, along with a Motion to Admit Mr. Warnken’s testimony into the record.


