The Citizens' Utility Board of Oregon (CUB) releases a total of \$12,000 from the following Issue Fund Grants: \$5,000 from the PGE Issue Fund; \$5,000 from the PacifiCorp Issue Fund; and \$2,000 from the Idaho Power Issue Fund.

On February 4, 2011, CUB submitted a proposed budget of \$12,000, assuming a fully litigated case. On February 8, 2011, the Public Utility Commission approved a budget of \$12,000 for CUB in Order No. 11-049. CUB does not intend to request any payment from this budget, and requests that this money be made available for intervenors in other dockets, as appropriate.
