Staff submits this status report on behalf of the parties. The parties participated in a settlement conference call on November 7, 2013. At the time of that conference, the parties were aware that the Federal Communications Commission (FCC) had issued to i-wireless a Notice of Apparent Liability for Forfeiture alleging violations of the federal Lifeline rules. *In the matter of i-wireless*, LLC, FCC 12-148 (Released November 1, 2013). Staff and the Citizens' Utility Board of Oregon requested the opportunity to review any response filed by i-wireless to this Notice before engaging in further work related to settlement of the issues in this proceeding. The company agreed and will provide a copy of its response to the parties. The company's filing with the FCC is now due to be filed by January 10, 2014.
