On January 27, 2012, T-Mobile West Corporation (“T-Mobile” or the “Company”) filed a status update indicating its intentions with respect to the Eligible Telecommunications Carrier (“ETC”) application pending in this docket (“Application”). The update stated that the Federal Communications Commission (“FCC”) planned to address issues related to the Lifeline program at its Commission Meeting on January 31, 2012, and that T-Mobile expected to file an amended application within the next thirty days after the FCC’s anticipated order was released.

The FCC issued its order on February 6, 2012. The Company is currently evaluating the FCC’s order and plans to file an amended application within 30 days of this status update. Should the Company’s plans change in the interim, the Company will provide the Commission with a further update.


