Pursuant to your Ruling of January 13, 2012, T-Mobile West Corporation ("T-Mobile" or the "Company") files this update indicating its intentions with respect to the Eligible Telecommunications Carrier ("ETC") application pending in this docket ("Application").

The Federal Communications Commission ("FCC") is planning to address issues related to the Lifeline program (which is part of the federal Universal Service Fund) at its Commission Meeting on January 31, 2012. T-Mobile expects to file an amended application within the next thirty days after the FCC's anticipated order is released.

Therefore, T-Mobile requests that it be permitted to file a status update by February 29, 2012 informing the Commission of T-Mobile's intentions with respect to the Application, unless T-Mobile has already made a filing requesting action by the Commission in this docket.
