
Dear Judge Hardie:

On July 11, 2012, the above-referenced docket was suspended to allow the Energy Trust of Oregon's (ETO's) Conservation Advisory Council (CAC) time to review certain policies of the Energy Trust and decide whether they should be modified.

The CAC met on July 25, 2012 and discussed Energy Trust incentive policies. The CAC was asked to provide input only and was not asked to agree to or recommend any specific ETO actions with regard to these policies. The CAC did not come to any consensus regarding current incentive policies nor modifications to those policies.

Staff supports scheduling a prehearing conference to discuss a date by which the Parties may return to the procedural schedule previously established in this docket on May 15, 2012.


