Attention Filing Center:

Idaho Power Company ("Idaho Power" or "Company") does not intend to file opening testimony in this docket. The purpose of this docket is to review the treatment of pension expenses, and specifically the treatment of prepaid pension assets.¹ Idaho Power is uniquely situated among the utilities that are parties to this docket in that the Company does not have a prepaid pension asset and is not incurring any financing costs associated with a prepaid pension asset. Therefore, Idaho Power does not have a proposal regarding the regulatory treatment of prepaid pension assets.

While Idaho Power is not filing opening testimony, the Company may participate in this docket as appropriate and reserves the right to file responsive testimony to the extent other parties make recommendations that will impact the Company.
