Staff is filing this status report on behalf of the Parties. The Parties reached an agreement in principle on a set of terms for annual ETC reporting requirements at the April 4, 2014 workshop and are in the process of finalizing and executing a second partial stipulation and joint testimony in support of that stipulation. The Parties anticipate filing these documents by May 15, 2014.

Also at the workshop on April 4, 2014, the Parties agreed to hold two workshops beginning in July 2014 to initiate discussion of the issues in Phase II of this docket. Specific dates have yet to be scheduled, but once they are, Staff will notify the Administrative Hearings Division.
