Staff files this status report regarding Phase II of this docket. Since the last status report was filed in this case, the parties have held two workshop/settlement conferences addressing initial application requirements for Eligible Telecommunications Carriers (ETCs). The first was held on September 8, 2014. The second was initially set for September 19, 2014, but was rescheduled to October 15, 2014. The parties require additional time to discuss all remaining issues. Accordingly, another workshop/settlement conference has been scheduled for November 4, 2014.
